## Minutes of 03-07-22

Pie calls the meeting to order at 6:01 PM.

Pie led the pledge of allegiance.

Roll call: Dan Cousar absent, Ben Hill present, John Hindy present, Pie Medina present, Andrew Harter present, Jacqueline Jacobs present, and Nikki Cross present.

Reading of the agenda: Pie added training to the agenda. Nikki made a motion to approve the agenda with corrections while John seconds. All in favor, motion carries.

Public comment: Pie asked the public if anyone had any comments on the agenda. No one had any statements regarding the agenda.

Approval of the minutes: Ben asked Jacqueline several questions about the lists that were given to Mr. Moore in the Fall and what was or wasn't included.
