**Fire:** Chief Dailey gave report. PFAS testing was all in compliance. Great Result. There is a new set of Rules from the fire Marshall. Fire Fighters cannot move up without extra classes. **Sewer/water & Maintenance:** Trees have been removed from the Youth Park sign, making it more visible. There are 3 more trees hanging over the power lines that need to be removed for a cost of \$2000.00 + \$400 for the stump removal. **Parks/Rec.:** Projects that we would still like to accomplish: vaulted toilet, fire ring, drinking fountain, and a double grill for the pavilion.

### **Ongoing Business:**

We had an emergency repair for one of the fire trucks. Original estimate was \$3100. Cost ended up being \$4465.56 Supervisor Wogatzke and Trustee Cousar approved the cost of emergency repair. Board has approved of the emergency decision.

**Property Offers:** 

Andrew Harter had previously offered \$1600.00 for swampy lots. Motion by Dan Cousar, supported by Kathy Young to un-table this offer. Roll call vote: Kelly McCune yea, Dan Cousar yea, Pat Williams yea, Kathy Young yea, Ernie Wogatzke yea. 5 yea 0 nay motion carries. The SEV for the property is \$1300.00. Motion made by Pat Williams, supported by Kathy Young to counter offer the sale for \$1300.00. Roll call vote: Kelly McCune yea, Dan Cousar yea, Pat Williams yea, Kathy Young yea, Ernie Wogatzke yea. 5 yea 0 nay motion carries.

Louise Russell previously offered \$5300.00, for one of the properties on 36<sup>th</sup> Street (1882 W. 36<sup>th</sup> St.). The township has invested \$5394.58 into the yard clean up and the building clean up. Motion by Pat Williams supported by Dan Cousar to counter offer \$5394.58. Troy Barker had previously made an offer on a lot he said was contiguous to his property. Further investigation shows that it is not contiguous. Motion by Pat Williams, supported by Dan Cousar to revoke the sale of Lot 28. Roll call vote: Kelly McCune yea, Dan Cousar yea, Pat Williams yea, Kathy Young yea, Ernie Wogatzke yea. 5 yea 0 nay motion carries.

#### **New Business:**

Budget Workshops: dates for the budget workshops are set for June 7<sup>th</sup>, June 14<sup>th</sup>, at 6:00 p.m. and annual budget meeting to be held June 25<sup>th</sup>, 2022 at 9:00 a.m. All in favor, motion carries.

Trustee Cousar states that he will be requesting to purchase property from the Township in the near future. He will not vote or take part of any discussions.

Fire Mileage: need to see when it needs to go back on the ballot.

Refuse Assessment: need to see when that needs to be put on a ballot.

Spending Resolution: To clarify, \$500.00 limit per purchase for the maintenance and Fire Dept., and Department heads. We will remove the word "small" from the resolution. Motion by Pat Williams, supported by Kelly McCune to approve the clarification and removal of the word "small". Roll call vote: Kelly McCune yea, Dan Cousar yea, Pat Williams yea, Kathy Young yea, Ernie Wogatzke yea. 5 yea 0 nay motion carries.

**Public Comment:** Complaint about FOIA charges, questions about employee hours, concerns about dollar amounts on reports, differences on A-1 billing, concern about the former clerk's name remaining on packages (she must call and remove her name). New Co. Commissioner spoke about the radio planes. Questions regarding GEO paying for repairs to the pump, concerns about Wonderland & M-37.
