Approval of Accounts Payable:

General Fund: Motion by Pat Williams, supported by Kelly McCune to approve the General Fund. *Question by Trustee Cousar about 2 charges to the visa. The clerk will check into this. Treasurer's Report: Given by Pat Williams. The 24-month CD has reached maturity date. Motion by Dan Cousar, supported by Kelly McCune to roll the CD over. Treasurer Williams states that she needs approval to open a separate bank account for fire assessment with the same signers as all other accounts. Motion by Pat Williams, supported by Kelly McCune to approve the separate account for the fire assessment, with the same signers as all other accounts. Correspondence: Email from the attorneys regarding possible marijuana money being used for the new fire truck. Lake County Road Commission brining estimate/agreement. Motion made by Pat Williams, supported by Kelly McCune to approve the agreement with the County Road Commission for road brining. Roll call vote: Kelly McCune yea, Dan Cousar yea, Pat Williams yea, Kathy Young yea, Ernie Wogatzke yea. 5 yea, 0 nay motion carries.

Public Comment: *CORRECTIONS*: question asked about the attorney bill, and question about the attack on the park employee being in the hospital, questions regarding the mileage that the zoning administrator claimed on his time sheet. Question regarding who is filling out the zoning admin time sheet. Accusations of it not being his writing. Statement that a FOIA request on the Aflac insurance was wrong. Clerk will check into it and get the correct paperwork. Question regarding dates of public hearing. Question regarding a special meeting on Jan. 18th. Question regarding if park attendant was put on a payment plan. Statement regarding whether public meeting or special meeting was legal. Concerns regarding money spent on publications and mailings, then things changing. Question regarding proper procedure for the public hearings. Concerns about the township holding a blank check every year for the new fire truck, possibility of deception in the election. More statements on keeping track of the mileage. Questions regarding signatures on the bank card, accusation of one signer having a "record".

Department Reports:

Fire: Chief Dailey gives run report for the last month. Chief states that they have 1 new hire. And the FDIC training in Indianapolis is coming up again in April. He is giving a heads up that he would like approval to send four firefighters down, cost would be \$75.00 p/person, with Room charges for 3 days.

Water/Sewer: We have fallen below our contract agreement with the Village of Baldwin. It is suggested that we request a new contract with the closing of GEO prison.

Co. Road Commission: N/A

County Commissioner: Clyde Wellford gave a report on the commissioners meeting. It entailed, in part, GEO water/sewer usage and revenue. Also, the use of Narcan has become very popular and free to anyone.

Sheriff: Sheriff Rich Martin gave report on the ORV meeting. He states that there are no significant changes for road openings or closings. He reported on the fatal accident in Chase last month and what happened there.

Grant Writer: Trustee Cousar states that before we look for grants, we need to look at the Capital Improvement Plan and identify projects, then identify priorities, then seek out grants to

help with that. It was suggested that Trustee McCune might help with the grant writing process. She agrees that she would like to do that.

Co. Parks/Rec.: Supervisor Wogatzke reports that they are on task with the projects.

Zoning Admin: Supervisor Wogatzke gives report for Chris, since he is away at training.

Planning: Trustee McCune reports that the By-Laws are complete, and give the clerk a draft. She will furnish the board with a final copy. Trustee McCune states there is an MTA training March 15, 2023, that would be beneficial to all members. Cost is \$125.00 p/person (7 members=\$875.00), plus approximately \$300.00 Mileage (Frankenmuth) for at least 2 cars. Motion by Kathy Young supported by Pat Williams to send the Planning Commission to the MTA Frankenmuth training for up to \$1200.00 total. The water course development ordinance is back from the county with approval.
