- perspective. The area needs to be rezoned properly on the map. It appears the software Mr. Moore has isn't lining up with our maps.
- 2. An ordinance to amend Section 13.04. Part B needs to be changed from West to East in part B. Part A needs to be removed.
- 3. An ordinance to amend Live/Work and Mixed Use. In Section 18.22 part B was decided to be taken out that limits the residents of the dwelling.
- 4. An ordinance to rezone Arrowhead Village to Manufactured Housing Community as well as move the designated Manufactured Housing from West 32nd St. The Planning Commision has had prior discussion about using Arrowhead Village as a designated Manufacturing Housing Community not rezoning the area. It was discussed again that rezoning Arrowhead is not what Planning members want. West 32nd designated Manufactured Housing Community area was always LI and shouldn't be rezoned to R2.
- 5. Rezone of Putman Campground. Questions arose whether the requirements were made to rezone this area prior. All three parcel numbers need to be added to the ordinance.

Ben had a list of things that he wanted to make sure were being addressed. Jacqueline stated Mr. Moore has all four lists. Pie stated she wanted to schedule a public hearing at the next meeting.
